Notice Regarding the Status of Share Repurchase

(Acquisition of Own Shares Under the Provisions of the Articles of Incorporation Pursuant to the Provisions of Article 165, Paragraph (2) of the Companies Act)

Sakai Moving Service Co., Ltd. (the “Company”), at a meeting of its Board of Directors held on August 8, 2025 resolved to repurchase its own shares in accordance with Article 156 of the Companies Act (the “Act”) applicable pursuant to Paragraph 3, Article 165 of the Act.
